In New Hampshire: This fertilizer contains phosphate. In New Hampshire, phosphate fertilizers may only be used for turf maintenance in golf courses, parks, athletic fields, and sod farms.

Country Club 28-7-14 is specifically formulated for use on golf course putting greens and other turfgrass areas. It is completely soluble in cold water, and may be applied through any type of proportioner, spray or metered application.

Regular use of Country Club 28-7-14 will promote good growth and color with a minimum build-up of harmful soluble salts. Light frequent applications, depending upon individual conditions and feeding practices are best.



Directions

FOR PUTTING GREENS: Use weekly, if desired, at the rate of 1 Lb. per 1,000 sq. ft. in 1/2 to 2 gallons of water. This amount will supply 1/4 LB. of nitrogen per application.

FOR LAWNS, TEES, FAIRWAYS AND ATHLETIC FIELDS: Use as required at the rate of 2 LBS. per 1,000 sq. ft. in 1/2 to 2 gallons of water. This amount will supply 1/2 LB. of nitrogen per application.

NOTE: When turfgrass is under stress because of drought, disease, hot weather. etc., it is advisable to increase the amount of water used. The amount of fertilizer, water and frequency of application should be determined and adjusted according to turfgrass requirements, prevailing-conditions and feeding practices.

Country Club 28-7-14 is compatible with most commonly used pesticides and fungicides. Because types of chemicals and conditions vary widely, compatibility of eah chemical used with the fertilizer solution should be determined before combining them.
