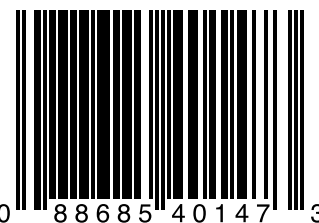

Application Rates

To feed at the rate of 1 lb. Phosphate (P₂O₅) per 1,000 sq. ft., apply this product at 5 lbs per 1,000 sq. ft. or 218 lbs. per acre.
 To feed at the rate of ½ lb. Phosphate (P₂O₅) per 1,000 sq. ft., apply this product at 2.5 lbs per 1,000 sq. ft. or 109 lbs. per acre.
