Application Rates

To feed at the rate of 1 lb. Phosphate (P,O₂) per 1,000 sq. ft., apply this product at 4.2 lbs. per 1,000 sq. ft. or 183 lbs. per acre. To feed at the rate of 0.5 lb. Phosphate (P_2O_3) per 1,000 sq. ft., apply this product at 2.1 lbs. per 1,000 sq. ft. or 92 lbs. per acre.
