To feed at the rate of 0.9 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 3.1 lbs per 1,000 sq. ft. or 135 lbs. per acre.

To feed at the rate of 0.7 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 2.5 lbs per 1,000 sq. ft. or 108 lbs. per acre.

To feed at the rate of 0.5 lb. Nitrogen (N) per 1,000 sq. ft., apply this product at 1.8 lbs per 1,000 sq. ft. or 74 lbs. per acre.
