ENVIRONMENTAL HAZARDS

Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer is highly toxic to aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

DIRECTIONS FOR USE

It is a violation of Federal law to use Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer in a manner inconsistent with its labeling.

Do not apply Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirement specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), and restricted -entry interval. APPLICATION TO TURFGRASS

The use of Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer will provide plant nutrients as well as providing control of selected insect pests. Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer can be used for the control of soil inhabiting pests of turfgrass, for example northern & southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; European chafer, Rhizotrogus majalis; Green June beetle, Cotinus nitida; May or June beetles, Phyllophaga spp.; Japanese beetle, Popillia japonica; Oriental beetle, Anomala orientalis; Euetheola humulis rugiceps; sugarcane beetle, Euetheola humulis rugiceps, billbugs, Sphenophorus spp, annual bluegrass weevil, Listronotus maculicollis. Black turfgrass ataenius, Ataenius spretulus; Aphodius spp.; crane flies, Tipula spp., and mole crickels, Scapteriscus spp. Use Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer as directed on turfgrass including home lawns, school grounds, nursing homes and hospital grounds, city, county, state, municipal and federal grounds, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, churches, cemeteries, parks, playgrounds, athletic fields and sod farms.

The active ingredient in Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated turf must be in such a condition that the rainfall or irrigation will penetrate vertically into the soil profile.

APPLICATION TO ORNAMENTALS

Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer can be used as a broadcast application on ornamentals in commercial and residential landscapes, as well as on landscaped areas of golf courses and other recreational areas. This is a systemic product, with the active ingredient being absorbed by the roots and translocated upward within the plant. Optimum control will be achieved when applications are followed by sufficient mechanical incorporation, irrigation or rainfall to place the active ingredient into the soil. Make application prior to anticipated pest infestation to achieve optimum levels of control. Applications of Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer cannot exceed a total of 200 lb (0.4 lb of active ingredient) per acre per year

RESTRICTION: Not for use in commercial greenhouses, or nurseries.

APPLICATION EQUIPMENT

Apply Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer uniformly over the area being treated with typical granular application equipment. Both drop-type and rotary-type spreaders may be used to apply Lebanon Pro Brand fertilizer with Merit 0.2% Grub Preventer. Avoid the use of spreaders which would apply the material in narrow, concentrated bands. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly and accurately.
